

PERMIT & AMENDMENT FEES

FOR TRADE PROMOTION LOTTERIES / GAMES OF CHANCE

Calculated on the total retail value of prizes to be distributed

Permit fees

NSW

The fees listed below are for on-line NSW applications. If applying manually, an additional \$50 processing fee is applicable.

\$10,001 – \$50,000	\$ 300.00
\$50,001 – \$100,000	\$ 550.00
\$100,001 – \$200,000	\$1,050.00

Please note:

- Permits are not required for TAS, WA or QLD.
- Permits in NT are only required for promotions valued at \$5,001+ and where no other State/Territory has issued a permit.
- The VIC and SA permit fees, once paid, are non-refundable for any reason.
- The ACT permit fee, once paid, is non-refundable if “assessment” of the application by the Department has already commenced. If “assessment” has not yet commenced, the Department may refund the original permit fee paid, however they will deduct a fee of \$46 (from the fee originally paid) for cancelling the application.

Amendment fees

NSW If promotional dates are extended outside the original dates after the permit has been issued, the Department requires the same amount as the permit fee originally paid.

ACT	\$ 46.00	For any amendment to a permit application with a total prize pool of less than or equal to \$5,000; OR
	\$ 91.00	For any amendment to a permit application with a total prize pool of greater than \$5,000.

VIC \$187.00 For any amendment to the permit application.

SA \$ 50.50 For any amendment to the permit application

SA

You do not require a permit in SA if the total prize pool is less than \$5,000 and the draw is conducted electronically or manually. If there is an instant win element a permit will be required regardless of the total prize pool value. You may now also pay a premium fee if you wish to ensure that your permit number is issued within 5 business days.
